Client Authorization & Terms - Boarding/Daycare

Ruff House South cannot guarantee toys, blankets or beds will be returned in the same condition as delivered to us.

Dog owner understands the risks involved with communal boarding of dogs. Your dog will play inside and outside with other dogs. Although we offer reasonable care, the unpredictable personality of dogs can sometimes lead to injury or spreading of illnesses, such as Kennel Cough.

In case of an emergency the pet sitter will contact the owner using the phone numbers on the introduction form. The owner will then instruct the pet sitter of their next action. If the pet sitter cannot contact the owner the emergency number from the introduction form will then be called. If no contact is made the pet sitter will then be authorized to transport the pet to their requested veterinarian practice and seek medical care.

Owner agrees that if dog becomes ill or if the state of the dog's health otherwise requires professional attention, Ruff House South, in its sole discretion, may engage the services of a veterinarian of our selection or administer medicine or give other requisite attention to the dog, and the expenses thereof shall be paid by the owner. Owner gives consent to Ruff House South to act in the owner's behalf in obtaining emergency veterinary care at owner's expense if deemed necessary by Ruff House South.

Owner assumes any and all expenses or liability for injuries that owner's dog may inflict on any human or other dog while in the facility. Owner agrees to indemnify and hold Ruff House South and its employees harmless from any and all expenses and liability incurred as a result of injuries owner's dog inflicts upon any human or other dog while in the facility.

All dogs must have an identification tag with either a phone number or address of the owner. All dogs must be on leash when entering or leaving the premises.

By signing below, I understand and agree to abide by any and all policies outlined in this agreement; and, that this agreement constitutes the sole and entire agreement between us concerning your dog. This agreement shall be covered by Florida law.
