Client Authorization & Terms - Home Visits

In case of an emergency the pet sitter will contact the owner using the phone numbers on the introduction form. The owner will then instruct the pet sitter of their next action. If the pet sitter cannot contact the owner the emergency number from the introduction form will then be called. If no contact is made the pet sitter will then be authorized to transport the pet to their requested veterinarian practice and seek medical care. All costs will be covered by the owner.

Owner agrees that if dog becomes ill or if the state of the dog's health otherwise requires professional attention, Ruff House South, in its sole discretion, may engage the services of a veterinarian of our selection or administer medicine or give other requisite attention to the dog, and the expenses thereof shall be paid by the owner. Owner gives consent to Ruff House South to act in the owner's behalf in obtaining emergency veterinary care at owner's expense if deemed necessary by Ruff House South.

Ruff House South accepts no responsibility for security of the premises or loss if other individuals have access to the home during the term of this agreement. During all assignments, Pet sitting will only be carried out by Ruff House South owner or employees unless prearranged with the client.

Ruff House South is not responsible for damage sustained by a pet escaping because of a faulty leash/collar or a collar that is not properly fitted, nor will they be liable for unsecured escape routes in the client's home/yard.

Ruff House South shall not be held responsible for any damage to the client's property, or that of others, caused by the client's pets during the period in which they are in its care. The client has advised Ruff House South of all situations, which will relieve it of liability for damage.
